Flood Alleviation Scheme & Invite to Come & Meet us

Some homes in your area have experienced flooding because sewers are not large enough to cope with the rainfall during heavy storms.

To reduce the risk of flooding we are planning a new sewer between numbers 22 and 52 Cray Road.

After consultation with the council, we have been granted permission to start work on the 29 January 2007 and expect to be finished by the middle of April.

While we carry out this work a temporary road closure will be in place. The diversion route agreed with the council and bus diversion information can be found overleaf.
