

PARKING AT LULLINGSTONE GOLF COURSE

Sencio Community Leisure are arranging to install a new barrier at the golf course car park. This will be token operated and customers will be provided with one at the point of sale in the Pro Shop. This will also have to apply to other park users who will be charged £1:00 for the token. Sencio will carry out advance notification of this scheme both in the Pro Shop and in the car park.

They have had to move in this direction to reduce both the abuse of the car park as we have had a number of cars abandoned here again recently and break-ins to customers cars. Sencio state that they have obligations to customers and their insurance company to try improve control over the area. Also they have been advised that the KCC are introducing pay and display in their car park at the Lullingstone visitors centre and therefore are anticipating an increase in the non-golf users of the car park.

ROAD CLOSURES

You will no doubt have noticed the yellow diversion signs that have littered our narrow country lanes over the last few weeks. They are part of a very long diversion for road works a few miles away.

Kent County Council are pre-patching four roads—Castle Farm Road, Shacklands Road, Firmingers and Rock Hill—in preparation for a surface dressing in the summer. The schedule for patching and the diversion routes is:

Castle Farm Road – Works will start on Monday 19th February 2007 and will last for 2 weeks.

The diversion will be via Redmans Lane, Rock Hill, Jubilee Road, Holybush Lane, Hewitts Road, the A224 Orpington By Pass Road and Shacklands Road.

Shacklands Road – Works will start on 5th of March 2007 and will last for 3 weeks. The diversion will be via Castle Farm Road, Redmans Lane, Rock Hill, Jubilee Road, Holybush Lane, Hewitts Road and the A224 Orpington By Pass Road.

Firmingers Road – Works will start on 26th of March 2007 and will last for 2 weeks. The diversion will be via Well Hill and Rock Hill.

Rock Hill – Works will start on 2^{nd} of April 2007 and will last for 3 weeks.

The diversion will be via Redmans Lane, Castle Farm Road, Shacklands Road, the A224 Orpington By Pass Road, Hewitts Road, Holybush Road and Jubilee Road.

The roads will be closed and parking suspended whilst the works take place. A diversion will be in operation. Access for residents will be available.

Should you have any queries, then contact John Reynolds (Design Engineer) at Kent County Council on 08458 247 800 The surface dressing of the above four roads is expected to start around the middle of June. It is only expected to take a few days but expect similar diversions. Kent County Council Highways are aware that their diversions are very long. They claim to always sign the diversion for the wider routes to accommodate larger vehicles. They are now aware that the diversions along Jubilee Road and Holybush Lane go along roads unsuitable for heavy goods vehicles. As "locals" we can, and should, use our own diversion routes where they are better than the "official" diversions.

<u>NEW ROOF FOR MISSION</u> <u>CHURCH</u>

After 113 years the roof on the Mission Church needed replacement. The new roof was funded by the church, local people and Shoreham Parish Council. When the roof was replaced the opportunity was taken to replace the 113 year old wooden cross.

At the morning service on Sunday 4th March the roof and new cross were blessed by Canon Leslie Virgo. In attendance were over twenty parishioners and ex-parishioners plus Shoreham (Civil) Parish Clerk—Barbara Ide and the PCSO Dave Birchall. It was good to see a few ex-parishioners who still hold Well Hill and the Mission Church in such affection. Well Hill is a special place. Let's endeavor to keep it that way for when the roof is next replaced in one hundred years time.
